TLI41218 Certificate IV in Transport and Logistics (Road Transport – Car Driving Instruction) is the qualification for people engaged in driving instructor job roles within the Transport and Logistics Industry.

You will learn how to instruct others to apply safe car driving behaviours when operating a motor vehicle, design and develop a learning program to instruct learner drivers and gain skills to run your own business, such as customer services, basic bookkeeping, and safety procedures.

- The safe operation of driving instruction vehicles and how to use the dual control systems.

### **Entry Requirements**

Learners must hold a current and unrestricted full Australian drivers licence and have the necessary language, literacy, and numeracy skills (LLN) to interpret and apply relevant information as well as:

- an interest in working in this industry
- the ability to implement discretionary judgement and decision making
- A Unique Student Identifier (USI)

Prior to applying to become an accredited driver trainer to the QLD Department of Transport and Main Roads, students must:

- be at least 21 years old
- hold a valid open class C vehicle driver licence issued in Australia or New Zealand continuously held for at least 1 year immediately prior to applying to TMR\*.

#### **Assessment Methods**

- Theory-based questioning
- Case studies, role plays and scenarios
- Demonstration of practical skills and competition of a Practical Skills Demonstration logbook

## **Study Commitment**

In order to undertake this qualification, students are expected to commit up to 618 hours\* of learning and assessment which includes:

- Online self-directed learning and assessment activities
- Online tutorials
- Face to Face classroom-based sessions
- Practical driving experience and assessment
