You are not eligible to make this application if your licence is suspended or cancelled or you are disqualified from holding or obtaining a driver licence in any Australian state or territory, or any other country.

Evidence of Identity (EOI) Requirements

You must give evidence of your identity. You may do so by showing your Qld driver licence, industry authority, marine licence indicator (conditions apply) or adult proof of age (APA) card. All cards must be current or expired by less than two years.

If you are unable to show one of the above you will need to present three other acceptable EOI documents and evidence of your Qld residential address. For a full list of acceptable EOI, evidence of residential address and change of name documents please refer to the Evidence of Identity Requirements for Individuals (form F4362) or visit www.qld.gov.au.

Medical Condition Reporting

You must tell the Department of Transport and Main Roads of any medical condition that may adversely affect your ability to drive safely. You may need a medical certificate confirming your fitness to drive. Your health professional may also recommend that your licence be subject to conditions.
