

Exemption from Learner Logbook Requirements Application

Transport Operations (Road Use Management) Act 1995

This form is to be used if you are applying for an exemption from the requirement to record 100 hours of supervised driving experience in a learner logbook before you are eligible to apply for a P1 provisional licence.

You may be eligible if you meet at least one of the following requirements:

1. No car available

You are able to prove that you do not have a car reasonably available to you to enable you to complete 100 hours of supervised driving experience.

Note: You are not eligible for an exemption if you have access to a car but the transmission (manual or automatic) is not of your preferred choice.

2. No supervisor available

You are able to prove that you do not have a supervisor reasonably available to you to enable you to complete 100 hours of supervised driving experience.

A supervisor is a person who:

- a. directs you while you are learning to drive
- b. holds an open licence and has held that licence for at least one year
- sits next to you in the front passenger seat while you are driving.

3. Limited access to a road network

You are able to prove that:

- a. you live in an area with a limited road network that prevents you from obtaining 100 hours of supervised driving experience in a variety of road and traffic conditions
- there is no significant benefit for you to satisfy the learner logbook requirements by driving on the available road network
- there is no reasonable likelihood of you moving from the area or having an opportunity to drive in an area with a diverse road network.

A **limited road network** is a small number of roads of the same kind, for example, an island with a single road around the island.

A **diverse road network** is a group of roads of different kinds, for example, single or double lane roads, intersecting roads.

Important information

If you have no car or supervisor available, a supporting person such as an immediate family member, carer or guardian must complete the supporting statement (included in this application) confirming your circumstances and detailing the reasons why you cannot complete the 100 hours of supervised driving experience. If this is not included your application cannot be assessed.

The lodgement of this application does not guarantee it will be approved. Your traffic history will be considered. Once received, your application will be assessed and you will be advised of the outcome within 21 days.

If your application is approved, you will be required to hold your learner licence for at least two years in the three year period prior to applying for your P1 provisional licence. You can send this application with the application fee (cheque or money order) by mail to—
