Acknowledgement of Risk and Danger

The course I am about to undertake has been developed by Queensland Transport in consultation with educational professionals and experienced motorcyclists. All care has been taken in the development of the training curriculum and the delivery of the training. The responsibility for individual rider safety, rests with the rider and I acknowledge that the training that I will receive is conducted in accordance with the Queensland Transport and Main Roads Q-Ride curriculum.

I acknowledge that motorcycle riding can be dangerous and by participating in the courses that I have applied for, I understand that during these training courses I am exposed to certain risks and dangers and that I am under certain obligations to follow instruction as provided.

In acknowledging that there is risk associated with motorcycle riding, I understand the following:

- That I may be injured, both physically and mentally, with the possibility of death
- That my equipment may be destroyed, damaged, or lost
- That other riders/drivers may ride/drive dangerously or with a lack of skill
- That road surface /conditions may be dangerous and may vary without warning
- That the provider of the training, or their representative in charge of the lesson, may have to make decisions that will terminate the lesson based on safety or performance
- That there may be limited or no facilities immediately available for treatment or transportation of me if I am injured
- That I have an obligation to myself and to other road users to ride safely and to abide by all rules and regulations laid down prior to and during the training and assessment portions of the course

I understand that I participate in this course at my own risk and that I accept that the training area as located at 3 Jondique Ave Merrimac has been risk assessed and is as presented.

I indemnify and deem harmless the provider and their representatives against any action or claims which may be made by me or on my behalf regarding injury, death, or property loss in any manner whatsoever.

Declaration of Eligibility for Q-Ride Training and Assessment

Transport Operations (Road Use Management) Act 1995

Use this form to declare that you are eligible to enrol in a Q-Ride training and assessment course for the issue of a Queensland (Qld) motorcycle licence. You will also need to show your current driver licence to the Q-Ride Registered Service Provider (RSP) before you commence training. If you hold a foreign driver licence that is not in English you must show a recognised translation.

Your Q-Ride RSP may require you to provide a Q-Ride Course Eligibility Certificate or a driver licence history to confirm that you meet the eligibility requirements before accepting your enrolment. To obtain your driver licence history, you will need to complete a *Release of Information Application* (form F2121) and lodge it at a Department of Transport and Main Roads customer service centre and pay the applicable fee.

1. Q-Ride course enrolment and eligibility

To enrol in a Q-Ride course you must meet eligibility requirements. Please tick one of the boxes below to indicate the licence you currently hold which aligns to the course you are enrolling in.

Pre-learner course:

- ☐ a current class C provisional, probationary or open licence (or interstate or foreign licence equivalent) and have held it for at least one year.

Restricted (class RE) course:

- ☐ a class RE learner licence
Note: If issued after 1 October 2016 and completed a pre-learner course, you must have held it for at least three months, or if you were exempt from the pre-learner course you must have held it for at least one year.
- ☐ an interstate or foreign motorcycle learner licence and have held the licence for at least three months
- ☐ a foreign motorcycle licence equivalent to a class RE or class R provisional or open licence
- ☐ a licence with an 'RD' condition, and a Returning Driver Certificate stating you can learn to ride a motorcycle.

Note: If issued before 1 October 2016, you are eligible to do the unrestricted (class R) course after one year.

- ☐ a licence with an 'RD' condition, and a Returning Driver Certificate stating you can learn to ride an R motorcycle.

Important note: Your driver licence must not be expired, suspended or cancelled and you must not be disqualified by order of an Australian or overseas court from holding or obtaining a driver licence.
